BACKGROUND

The United Bulawayo Hospitals is situated in the Eastern part of the city of Bulawayo. It is one of two principal referral centres for the Southern part of the country. The hospital also serves as one of the two referral centres for an urban population of about one million. It also serves population from Mat. South, Masvingo and Midlands Provinces. United Bulawayo Hospitals was opened in 1937 at Kumalo as an extension of the Old Memorial Hospital.

PROJECT SCOPE

Firm or Consortium will be responsible for assessing, construction, refurbishing, re-equipping and upgrading of:
